

2025 All Star Interest Letter

*This form must be completed by May 1, 2025. Late submissions will not be accepted.

GENERAL INFORMATION:

• All-Star team selection will occur at an All-Star Selection Meeting on or shortly after May 1, 2025. Not all players who express interest will be selected.

• The All-Star Season will begin May 5, 2025 and will conclude around the last week of June 2025. Should the team qualify for States or Nationals, participation at those tournaments is mandatory and may extend later into July 2025.

• Players will be expected to participate in all team functions including practices, tournaments, meetings, and fundraisers set forth by OFSA and the team manager.

• Practice schedules are determined by each team's manager and can range from 3 to 5 days a week, for two hours plus.

• Excluding post-District tournament play, the tournament schedule will include 2-3 tournaments in Southern California, beginning May 2025. Additional tournaments participation varies on the team's commitment.

• Players are not guaranteed any specific fielding position or playing time on the All-Star team. The coaching staff will determine the positions and the amount of playing time. The coaching staff has the final say in all matters relating to player positions and playing time.

• Missed practices may result in less playing time at the manager's discretion.

• Parents and players agree to abide by the standards of conduct that are part of the USA Softball National Code, all tournament rules, and any other guidelines or policies supplied by USA Softball, OFSA, or hosting tournament.

FINANCIAL COMMITMENT:

• The initial financial commitment for 6U All-Stars is \$300 and is the sole responsibility of the Parent or Guardian. Please note, prices may increase due to tariffs. The initial fee includes USA Softball All-Star membership fee, tournament and administrative fees, field fees, a bat bag, two jerseys, one pair of pants, and one batting helmet. Additional costs associated with the All-Star program may include travel expenses (such as commuting, lodging and meals) equipment, spirit wear, team swag, etc. and may accumulate to an excess of \$1,000. All costs are the responsibility of the parent or guardian. Payment of

\$150 will be due no later than May 2, 2025. Remaining payment of \$150 will be due no later than May 16, 2025.

• Each team is required to fundraise and acquire sponsorships. Fundraising opportunities and a fundraising template will be provided to assist in the process.

• Your submission of this interest letter for consideration and participation in All-Stars confirms your acknowledgment of all costs associated, as well as your understanding of your obligation to pay.

• The Following tournaments have been chosen and paid for. All other tournaments will be at the coaches discretion.
